

**AN ORDINANCE OF THE MAYOR AND COUNCIL OF THE CITY OF
“CENTERVILLE” GEORGIA AMENDING CITY ORDINANCE SECTION 60-23 “WATER
AND SEWER RATE SCHEDULE,” (AS SET FORTH IN CHAPTER 22, SECTION 60-23),
PROVIDING AN EFFECTIVE DATE, AND FOR OTHER PURPOSES.**

WHEREAS, each residential and commercial consumer of the City of Centerville’s water and sewer services shall pay for those services in accordance with the latest adopted fee schedules of the city, and

WHEREAS, the following water and sewer rate schedules are adopted effective with the July 2010 billing cycle for all such residential and commercial consumers:

0-2,000	gallons, minimum	\$ 14.92
over 2,000	gallons	\$ 1.53 per 1,000 gallons

0-2,000	gallons, minimum	\$ 17.30
over 2,000	gallons	\$ 1.96 per 1,000 gallons

NOW, THEREFORE, be it ordained that City Ordinance Section 60-23 is hereby amended as noted above.




